**ASSIGNMENT AND ASSUMPTION
 OF DECLARANT'S RIGHTS AND OBLIGATIONS

KNOW ALL PERSONS BY THESE PRESENTS:

WHEREAS, DEBRA, INC., a Florida corporation, whose address is 2100 South Hiawasse Road, Orlando, Florida 32811 ("Assignor"), has conveyed to LESLIE, L.L.C., a Florida limited liability company, whose address is c/o SouthStar Development Partners, Inc., 255 Alhambra Circle, Suite 312, Coral Gables, Florida 33134 ("Assignee"), certain real property subject to the Declaration hereinafter described (the "Property"); and

WHEREAS, the Property is encumbered by that certain Declaration of Protective Covenants and Restrictions for MetroWest recorded March 13, 1986 in Official Records Book 3759, Page 2756; Agreement Concerning Transfer of Responsibilities recorded September 17, 1986 in Official Records Book 3820, Page 4314; Supplement No. 1 to the Master Declaration of Protective Covenants and Restrictions for MetroWest recorded August 20, 1987 in Official Records Book 3913, Page 2944; Supplement No. 2 to the Master Declaration of Protective Covenants and Restrictions for MetroWest recorded November 17, 1987 in Official Records Book 3936, Page 4185; Supplement No. 3 to the Master Declaration of Protective Covenants and Restrictions for MetroWest recorded March 28, 1988 in Official Records Book 3968, Page 1279; First Amendment to Master Declaration of Protective Covenants and Restrictions for MetroWest recorded August 30, 1996 in Official Records Book 5114, Page 1077, all of the Public Records of Orange County, Florida (collectively, the "Declaration"); and

WHEREAS, Assignor is the Declarant under the Declaration; and

WHEREAS, Assignor has agreed to assign to Assignee all of Assignor's rights, privileges, powers, authorities, liabilities and obligations as the Declarant or the Developer granted or reserved in, to and under the Declaration (collectively, "Declarant's Rights and Obligations"), and Assignee has agreed to accept and assume Declarant's Rights and Obligations from and after the date hereof.

NOW, THEREFORE, for and in consideration of the sum of Ten Dollars (\$10.00) and other valuable consideration the receipt and sufficiency of which are hereby acknowledged by Assignor and Assignee, Assignor does hereby assign and transfer to Assignee, without representation or warranty, all of the Declarant's Rights and Obligations and Assignee hereby

accepts, assumes and agrees to perform and abide by all of the Declarant's Rights and Obligations from and after the date hereof.

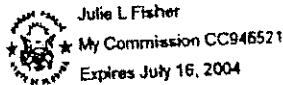

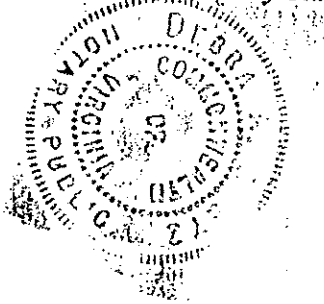
